Membership may be **renewed annually or quarterly**, depending on the selected package. Renewal must be **confirmed and paid in advance** to avoid suspension of access.
 - **Member-Only Access**
The Gym is strictly for **registered members only. Guests are not permitted** under any circumstances.
 - **Lost Card Replacement**
In the event of a lost card, a **replacement will be issued upon payment of RM50.00.**
 - **Damages and Liability**
Any member found responsible for **damaging or breaking gym equipment** shall be liable to **reimburse the Club** for the full cost of repairs or replacement.
 - **Compliance with Rules and Regulations**
All members must **comply with the Rules and Regulations** established by **Kelab Kidurong Bintulu Management**, which may be amended from time to time.
